Meeting called to order by President Barb Steffenson at 6:52pm. Quorum requirement: 35% (19) of our 54 voting Members. A quorum consisting of 29 voting members was present. • At the April 24, 2021 Special Congregational Meeting: Approval of allocation of funds from the Designated Building Fund #357, not to exceed \$90,000 which will accomplish the following steps in our "Building to Serve" Plan of Action: Driveway from Access Road, Parking Area, electrical Service, shelter and a portable storage shed, and necessary permits. Work to be performed by AB Systems (Peter Schuller);

• Our church picnic was held on our church land on 8/1/21;

• The following motion, approved by the council, will be presented to the Congregation for approval on January 29, 2022: "<u>Action Item</u> - Clergy PTO (Personal Time Off - Sick Leave Policy) ...

* At the September 9, 2021 Council Meeting a Motion was made by Don Holtan, and 2nd by Barb Steffenson, which carried unanimously, to adopt the following PTO policy for its pastor: "20 days of sick leave in a 12-month period; not to be accrued and carried forward from year to year. Also, in catastrophic situations, two additional months of sick leave will be provided to cover the individual until disability coverage begins." Funding will be taken from our General Funds and added as two Designated Items. One (#308) will cover the Pulpit Supply for up to 20 days (\$2,000). The second (#309) will cover the catastrophic situation (\$12,500.00, i.e. two months of salary). This will be implemented after congregational approval at the January 29, 2022 Emmanuel annual meeting."

Audit Committee Report

Church Financials were reviewed by Darald Bothun, Tom Vomhof, Don Wanek, Rachel Woodford on January 8, 2021. All records were found to be in proper order. Treasurer Judy Caudill was present. Church Financials were also reviewed on July 17, 2021.

NALC Convocation in Corpus Christi, TX (Judy Caudill)—August 2-6, 2021

The Theme for the 2021 Convocation was "<u>God the Father Creates</u>". *In the beginning, God created the heavens and the earth. The earth was without form and void, and darkness was over the face of the deep. And the Spirit of God was hovering over the face of the waters.* Genesis 1:1-2. In essence, God created everything out of nothing. He said let there be light and there was.

The entire Convocation experience was a gift to me that I will forever cherish. All of the speakers were great but there were a few that stood out to me that I would like to share. <u>The Bishop Rev. Dr. Daniel Selbo</u> started the Convocation stating that God is the Creator, who made us creatures as we are, and how life is given true purpose and meaning only as it is lived in a true relationship with Him. God was there from the beginning of time and even before time. He is the Almighty and all-powerful. He formed and fashioned all that exists and when this world comes to a close and a new world is created in its place (Rev. 21:1-4) it will be His creating power that will bring it about. Bishop Selbo reminded us that even with all the changes taking place in the world that God is in control. God knows what lies ahead. He is fully aware of what is needed now. He works at all times and in all things – past, present and future – to carry out and fulfill His saving purpose!

<u>Pastor Buba</u> had a message that really stood out to me. He said that Fear is our biggest obstacle in that it causes Christians to be afraid to witness to others about Jesus – especially in the United States. He said other countries (including even the Arab Emirates) are witnessing even though they may face death. He said ignore your fear and acknowledge that Jesus is with you! The world is in need of Jesus! The Word of God is forever true!

<u>Dr. Stephen Paulson</u> spoke at the teaching of the NALC Seminaries. Dr. Paulson is a professor of Lutheran Theology at Sioux Falls. We were reminded that formation of the NALC was to preach Christ faithfully and with renewed fervor and commitment is the heart of our mission and ministry. It is also the heart of our NALS network. Dr. Paulson stated again – God created all of us! – He created Adam and Eve to become one. He definitely is not "politically correct" as he will only teach scripture as it is written and not fit the world's narrative. What God creates is perfect and man cannot change that! If I were sending anyone to the seminary I would want them in his class. He doesn't change God's word to satisfy the audience.

Last but definitely not least the speaker for the Abortion Survivor's Network, Melissa Ohden. Her talk was an amazing story of God's work. Her biological mother was forced by her biological grandmother to have a saline infused abortion at 7 months into her pregnancy. She was in a saline solution for 5 days before the hospital induced labor on her mother. She was born alive. Her biological grandmother told the staff to leave her and let her die. A nurse took her into the NIC Unit of the hospital. After a long stay there she was adopted and didn't learn of the situation of her birth until her teen years. She went through years of shame and anger but through faith has now been able to forgive those involved. After 30 years she has connected with her birth mother who for those 30 years had been estranged from her parents as she was told her daughter was dead. She had asked to see her daughter after the procedure and was told the baby was dead & because of the procedure looked like a monster. Melissa has written a book "You Carried Me" and travels extensively talking with people about the tragedy of abortion and speaking to hundreds of abortion survivors. She is now in touch with her biological grandfather on her father's side (who knew nothing of the abortion or her existence) but he is now very involved in her & her daughter's life. The talk really inspired me to talk to others & to encourage anyone who is contemplating an abortion to look for help in order to be able to have their baby and give it up for a loving adoption if they are unable to take care of the little one.

My sister Deb Vomhof also attended the Convocation. We talked to so many wonderful people at the Convocation, Pastors, delegates, and just people from around the country and Canada that were amazing and very encouraging of the NALC. The experience was unforgettable and life-changing. The NALC Convocation for year 2023 will be held in Oklahoma City, Oklahoma, August 7-11. The 2022 Convocation will be virtual as it was decided during the zoom Convocation in 2020 to have the meeting virtual every other year to save funds. The 2022 Iowa Mission District Convocation will be held at Zion Lutheran in Ruthven, Iowa on Saturday, August 27.

Ten Goals and Mile Markers for 2022: In Celebration of our 10 year anniversary!

1. Ten Thrivent Action Team Grants – one for each year of our life together as Emmanuel Lutheran Church. Ten Featured Events: <u>examples</u>, SEMAC Mission Trip, Easter Monday Bible Reading, Memorial Day Celebration, VBS Event (10 hours on the Ten Commandments)—summer of 2022, Emmanuel Church Picnic, Reformation Sunday Prayer Walk, Fall Pumpkin Festival, Advent by Candlelight, etc.

- 2. 10% tithe for mission in 2022 on our Church Budget.

7. <u>Building for the Future Fundraising</u>: February 25, 2022 - Gifts of Ten (Ten - \$1; Ten - \$10; Ten - \$100; 10 - \$1,000; and 10 - \$10,000) = \$111,110.00.

- 9. Create a Church Membership Directory/10-year history & picture book.
- 10. Anniversary Celebration Event (Catered meal with a program?)

Pastor's Report: Rev. David Steffenson — "Grace Upon Grace"

<u>Grace</u>: "God's Riches At Christ's Expense." I don't take God's grace for granted, and I know that you don't either. St. John reminds us that from the fullness of Jesus, we have all received grace upon grace. God gives us grace stacked on top of grace. God isn't stingy when it comes to grace! God gives us grace saturated and immersed in more grace. God doesn't just give us a little bit of grace. God lavishes his love & grace upon us. When it comes to grace, God is extravagant. God is prodigal. Why all the grace? Grace is purpose-driven. Grace brings about our reconciliation, & our justification with God. <u>St. Paul writes</u>, "We are God's workmanship, created in Christ Jesus for good works which God prepared beforehand that we should walk in them." God has a catalogue of charity, an endless stockpile of good works, which God has prepared and predetermined beforehand for each one of us to accomplish. We are saved by grace alone, in Christ alone, through faith alone, <u>for good works</u>. Our words & deeds of love bring glory to our Heavenly Father as we let our lights so shine before others. Good Works. In-Deed! As I reflect on 2021, I am mindful of God's free and undeserved gift of grace. I have seen it personally in my battle with cancer and other health issues. I have seen it repeatedly in the life and ministries of Emmanuel.

After months of planning and praying, the members of Emmanuel (April 24, 2021) overwhelming approved (28-1) the construction of a driveway, a parking lot, an electrical hookup, a storage building and a shelter to be constructed on our church property. All funds are on hand and no borrowing of monies is needed. There was plenty of paperwork, bumps in the road, and setbacks along the way, but finally in the fall of 2021, construction began. Good Lord willing, we are hoping to have an Easter Sunday Worship Service on our church land on April 17. The Implementation Team has labored diligently; and members and friends of Emmanuel continue to offer their time, talents and treasures in generous support of God's dream for God's church land.

Some of our grace-filled highlights from 2021 include:

- 1. <u>Church Land Development</u>: The Implementation Team met regularly to recommend a Site Master Plan to the church council and the membership of Emmanuel Lutheran. (See Page 13)
- 2. <u>Signage</u>: We wanted to announce the presence of Emmanuel on our church land. A large sign (very readable) was placed on the land. The land is not the future home of Emmanuel, it is the present home of Emmanuel. The church is already here & there. The church is not a building; it's a people, living out their lives; called enlightened and sanctified for the work of Jesus Christ. Grace is purpose-given! LeRoy & Margaret Quam donated a large Eternal Cross for the church land. "Lift high the cross, the love of Christ proclaim!" (See July 2021 Emmanuel Newsletter)

- 3. <u>During Lent</u>, Julie Steffenson (Thrivent Action Team grant) organized a "Soup to Go" event. Members donated 300+ cans of soup for the Salvation Army Food Pantry. Members took some homemade soup home with them on Ash Wednesday.
- 4. We upgraded the <u>video & audio</u> quality of our weekly worship services. A training session was held and Jeff Patzke is now trained to fill in when Don Holtan is unavailable to run and record the sound system for worship. Don has also assembled a Training Manual. We offer thanks to Joel Simpson (Oasis musician) for assisting us in this upgrade and training. In 2022, Emmanuel will be budgeting dollars for copyright usage of hymns and liturgy in worship.
- 5. Emmanuel hosted <u>a virtual baby shower for New Life Family Services</u> in conjunction with a National Sanctity of Human Life Worship Celebration (Jan. 16-17). \$1,000+ in baby gifts were gathered; along with 600+ Facebook engagements. A Thrivent Action Team grant helped to support this ministry.
- 6. Emmanuel supported the <u>SEMAC Mission Trip to Pensacola, Florida</u> (Feb 7th–19th). Joe Vomhof secured a Thrivent Action Team grant in support of this mission trip.
- 7. Emmanuel hosted an <u>Easter Monday Bible Reading</u> of the New Testament (April 5). Jean Wanek secured a Thrivent Action Team grant in support of this ministry.
- 8. Once again, even with COVID-19, Emmanuel members enjoyed a <u>church family picnic</u> (August 1) on the church land. The weather was wonderful! Don Holtan secured a Thrivent Action Team grant in support of our church picnic.
- 9. Emmanuel hosted an in-person <u>Thanksgiving Worship Service and Pie Social</u> at 2pm on Thanksgiving Eve (November 24). Sharing Thanksgiving—we sent out 100 greeting cards. Jean Wanek secured a Thrivent Action Team grant in support of this activity.
- 10. We wanted to secure 10 <u>Thrivent grants</u> and we obtained 9. In addition to highlights mentioned above, I was able to secure a Thrivent Action Team grant for our Mini-VBS event, Joe Vomhof used his second Thrivent Action Team grant to support the SEMAC mission trip to Texas in May, Julie Steffenson used her second Thrivent Action Team grant to support the take-home Saturday School education materials, and Judy Pearce secured a Thrivent Action Team grant to share Advent cookies with area hospitality houses. Emmanuel is able to do so much more ministry with the assistance of Thrivent Action Team grants and Choice Dollars.
- 11. NALC (Rochester Area) Disaster Response Warehouse: currently being housed on the property of Larry & Deb Vomhof. Items are already being supplied and distributed to people in need!

Once again, <u>Emmanuel has ended the year in the black</u>; **six years in a row** with a budget surplus and no need to use our reserves. How is this possible, given the size of Emmanuel? All the credit goes to God. Our only boast is the grace of God. Two things have helped to produce our six years of budget surpluses, namely, God-given generous members, and God-given faithful benefactors. We have numerous non-members who see the value of supporting God's holy work at Emmanuel. Several churches and individuals pray for Emmanuel and generously support the work we do. I am grateful! When all is said and done, it is probably a really good thing that Emmanuel Lutheran is not self-sufficient. We are not able to balance our budget on our own backs. We rely upon the grace of God, at work in the lives of His people, to accomplish the good works God has prepared beforehand for us to walk there-in. It's good to know that grace has brought us safe thus far and grace will bring us all the way home.

As we enter 2022, we have much to celebrate. On <u>February 25</u>, Emmanuel will celebrate its 10 year anniversary. Some of you may recall that in February of 2017 we had a 5-year anniversary party with almost 150 people in attendance; even with a winter storm. In 2022, we are going to spend the entire year celebrating the grace of God. As much as possible we want to focus on the number 10. We have **Ten Goals for 2022. See page 5 of this report.**

Average Worship Attendance: Due to COVID, we have not been keeping track of average weekly worship attendance. In recent years, the Care Team has overseen this ministry. The church council, at its January 6 meeting, decided to disband the Care Team due to lack of membership for this committee. We give thanks to Julie Engle and Jean Wanek who labored faithfully in 2021 offering Christ-centered care to others. The Council believes that Emmanuel will continue to care for others on an individual basis as needs arise, and that we do not need a formal committee to oversee this ministry. If you see a need, and would like to have our church as a whole address this need, please contact me or a member of the church council. Funds are available to provide care and compassion to others.

The <u>daily ministry of 4:31</u> has been a highlight for me in 2021. We are all living on borrowed time. We receive each day as a holy gift from God. I'm not sure what 2022 will bring to me and you, but I know it will perfect and full of celebration. We serve a promising God who loves us with a forever love. The Emmanuel Implementation Team was appointed in November 2020 with the mission and charge from the church council to:

- a. Seek God's will for His Church, His land and His people
- b. Develop a church site Master Plan
- c. Solicit input and feedback from church members
- d. Identify, prioritize and implement necessary tasks in a timely manner
- e. Present all proposals to the church council and the congregation for approval

The Implementation Team (IT) was/is comprised of Pastor David Steffenson, Don Holtan, Judy Pearce, Larry Vomhof, & Don Wanek (resigned March 2021). Dan & MaryJo Grimsrud then came onto the IT. The Team accomplished a tremendous amount of work during the past 13-months, although much of the work may not be apparent to those who were not directly involved. Countless hours were devoted to research, coordination and planning. The <u>following items are some of the accomplishments thus far, but this is not an all-inclusive list</u>:

- a. Tree & brush removal. Burning of the debris was inhibited by the dry weather conditions.
- b. Aerial photography of the building site.
- c. Emmanuel Lutheran Church sign erected on land.
- d. Gym set installed for youth.
- e. Conditional Use Permit (CUP), the building permit application, was approved.
- f. Survey of land and grading were completed.
- g. Entrance road (gravel) from 18th Avenue completed.

h. Contract with AB Systems, Inc. as the general contractor/designer was signed by council president Barb Steffenson on November 24, 2021.

- i. Official address assigned: 1965 Emmanuel Drive NW, Rochester, MN 55901
- j. An eternal cross was installed beside the church sign.
- k. Concrete poured for shelter supports.
- 1. Vertical side supports for shelter have been erected.
- m. Colors & style of siding and shingles selected.

n. MaryJo Grimsrud has started compiling and coordinating an electronic and print media album chronicling the land site development. Please contact MaryJo if you have any pictures we can include in this historic record.

o. Workdays conducted onsite with more planned. Future dates will be announced.

Some projects are planned for completion during the winter, as weather permits, with the bulk of pending projects slated for this spring & summer. Your individual participation in the ongoing work will greatly enhance the development as we strive to complete it as economically and as quickly as possible. Your help might take the form of physical project work, planning and coordinating events, providing food for workers or contributing financial resources. <u>A primary goal for 2022</u>: Conducting our first official worship service in the shelter on Sunday morning April 17, 2022 – EASTER Sunday!

We have accomplished a lot. Much remains to be done as we bring Phase I of the project implementation to a close during the first half of 2022 and launch Phase II. As we look ahead, I am including a quote from renowned pastor, Christian author and teacher, Dr. David Jeremiah's book Forward about developing a plan of action in accordance with God's plan:

I extend my appreciation and thanks to the wonderful, hardworking Implementation Team and so many of our members who have provided valuable input, time, talent and resources into our church plan. Most importantly we thank the One for whom we labor, our Lord and Savior, Jesus Christ.

2021 Financial Summary Report: Judy Caudill, Treasurer

In 2015, we for ecasted a budget shortfall of \$18,000, but with second mile gifts we ended the year with a shortfall of only \$1,900. **In 2016,** we forecasted a budget shortfall of \$15,000, but due to generous giving by our members & supporters we ended 2016 with a surplus of \$9,548.37. **In 2017**, giving once again exceeded projections. Instead of ending the year with a shortfall of \$17,854 (from Reserves), we ended the year with a net gain of \$4,872.25. **In 2018**, we planned on using \$6,880.00 of our Reserves, but instead we ended the year with a surplus of \$2,477.45. **In 2019**, we budgeted for a shortfall of \$7,000, but instead ended the year with a surplus of \$8,242.42. **In 2020**, we budgeted for a shortfall of \$8,000, but instead, with the support of generous members, and the \$11,800 from the Government Payroll Protection Plan, we ended the year with a surplus of \$13,525.68 (Actual Surplus w/o PPP: \$1,725.68). **In 2021** we once again ended the year with a surplus of \$4,340.00. <u>During the past six years</u>, our annual budget surpluses have amounted to added reserves of \$43,006.17. We are blessed with generous and faithful members, friends, and church supporters. Thank you!

FYI - Vacation Policy for Emmanuel Lutheran

It is Emmanuel Lutheran's policy to encourage vacations for full time pastor(s) and full time lay staff to be taken as earned: To enjoy time with family and friends; to rest and rejuvenate. Deferred vacation for pastor(s) and staff who earned more than two weeks of vacation, may be accumulated to a maximum of six weeks. Vacation days earned, taken, and deferred is to be reported in the payroll process on a monthly basis so correct liabilities of Emmanuel Lutheran Church can be established and recorded properly. Date: Council Meeting, May 12, 2015.

FYI - Continuing Education Policy

Beginning in January of 2016, Pastor Steffenson's Continuing Education dollars and days may accumulate to a maximum of six weeks and \$2,250.00. Pastor receives \$750.00 and two weeks of continuing education each year. Date: Council Meeting, January 12, 2016.

Action Item - Clergy PTO (Personal Time Off - Sick Leave Policy)

At the September 9, 2021 Council Meeting a Motion was made by Don Holtan, and 2nd by Barb Steffenson, which carried unanimously, to adopt the following PTO policy for its pastor: "20 days of sick leave in a 12-month period; not to be accrued and carried forward from year to year. Also, in catastrophic situations, two additional months of sick leave will be provided to cover the individual until disability coverage begins." Funding will be taken <u>from our General Funds</u> and <u>added as two</u> <u>Designated Items</u>. One (#308) will cover the Pulpit Supply for up to 20 days (\$2,000). The second (#309) will cover the catastrophic situation (\$12,500.00, i.e. two months of salary). This will be implemented after congregational approval at the January 29, 2022 Emmanuel annual meeting.
